

Check-in procedure and sanitary measures adopted by Cinte Techtexsil China 2021

Dear visitors,

Cinte Techtexsil China 2021 will be held on **22 – 24 June 2021** at the Shanghai New International Expo Centre. Sanitary measure will be strictly performed on premise of ensuring the safety of all participants. Persons under 18 will not be admitted.

Arriving in China from foreign nations

- From 28 March 2020, the entry of foreign nationals holding valid entry visas and residence permits will be temporarily suspended. Foreign nationals holding visas issued after 28 March 2020 will not be affected.
- All inbound travelers will be subjected to 14 days mandatory medical quarantine upon arrival.
- All travelers from foreign nations will be required to have documentary proof for negative results for nucleic acid test for COVID-19 within seven days of the scheduled departure.
- All travelers arriving into China will be required to undergo a medical test for COVID-19 upon completion of all health, immigration, customs and quarantine clearance requirements.
- The test, which involves providing a saliva sample, will be conducted by medical professionals at the Department of Health of the local government.

Before the fair: Real name and ID number registration

To visit the show you must:

- ✓ **Pre-register online** in advance [HERE](#) using your **legal name, passport / travel documents number and China mobile number**
- ✓ If you have already pre-registered, please login and make sure all information is true and accurate
- ✓ If you have not submitted your travel document or ID number or mobile number, you'll need to register again onsite
- ✓ **Get your Shanghai Health code (随申码) AND Itinerary code (疫情防控行程卡) ^**, please see below for application details

*Each visitor must present BOTH green Health code and green Itinerary code together to enter the venue. If the Itinerary code has a remark * which indicates that you have passed through medium and high risk areas may change at any time, subject to the latest announcement), you need to present the original copy of the Certificate of Negative COVID-19 Nucleic Acid Test Result within 7 days before enter the venue (medium, high risk areas and the requirement may change at any time, subject to the latest announcement).*

Arriving the fairground: Badge and passport/ ID verification

To enter the fairground you must:

- ✓ **Bring your travel documents and e-badge with you** (ID card, passport or Mainland travel permit for Hong Kong & Macau Residents / Mainland travel permit for Taiwan Residents). **Photos and copies are invalid**
- ✓ **China citizens**
 - **Scan your ID card** at the Biometric turnstile

✓ **Overseas citizens including Hong Kong & Macau**

- Show your **e-Badge and redeem a real badge** by proving your original copy of travel document has been registered **at registration counters**.
- ✓ Cooperate with **body temperature monitoring** and show your "**Shanghai QR code (随申码)**" when entering the venue.
- ✓ **Please bring along the document proof of compulsory quarantine “完成隔离证明” to onsite.**
- ✓ **If you have entered or returned to Shanghai In the past 14 days, ensure you have your **NEGATIVE** nucleic test result within the 7 days period.**

For those personnel from high-risk city/ region in China, they are required to undergo a compulsory 14-day quarantine + 7-day community health monitoring & COVID-19 test for twice upon entry into Shanghai. Please click the link below for more details (Chinese version only).

- ✓ Attendees are also required to fill in the Health Declaration Form & undergo health checks prior to their entry into the registration area.

The 3 health status are as follow:

- (1) **Green Code:** Allowed to pass
- (2) **Yellow Code:** Observation is suggested
- Red Code:** Quarantine is suggested

Other sanitary measures set up for the show:

- ✓ **Wear medical mask is compulsory.**
- ✓ **Social Distance:** 1-meter interval will be set at registration area, seminar area and other common area.
- ✓ Hand sanitizers is available at registration area, information counters and entrances etc.
- ✓ Seminar area and translation audio headsets will be disinfected after every use.
- ✓ Public areas will be sterilized every hour while meeting rooms will be thoroughly cleaned after each use.
- ✓ Designated quarantine area and medical room will be ready
- ✓ Adequate ventilation will be ensured through the monitoring of fresh air supply.
- ✓ All clothing are not available to be stored in cloakroom, luggage only.
